Neighbor Profile

While we have a village with residents of many backgrounds, interests, and talents, I am not aware of many whose activities have ranged from fly fishing in the backwoods of Maine to entertaining an elderly beloved relative for frequent and extended visits. I speak here of one of our faithful dog walkers, Jini Pettijohn, (#740) whose life experience



has led her to enjoying peace and serenity here in Hershey's Mill.

Jini was born in Philadelphia, but the family relocated to Baltimore where she stayed throughout her school and early working

years. Following graduation, Jini accepted employment in the office of a local insurance company, and subsequently with Tate Engineering, a full-service mechanical equipment and systems provider.

Family considerations led to a move back to Philadelphia and a position with Keystone Shipping, a world-wide ocean-going tanker/shipping operation. Jini worked in the maintenance and repair department which oversaw dry dock and other repair work for a wide variety of vessels.

While working there, she met the man who was to become her husband. Bill performed multiple engineering and accounting tasks, kept track of ongoing repair work and its cost, and also oversaw the company pension plan.

Bill was a widower with three school-age children, and Jini became the at-home parent at Bill's home in Haddonfield, NJ, where she kept the family life moving smoothly. Jini was not one to be confined to the house, and became

very active volunteering with the West Jersey (now Virtua) Hospital Auxiliary. These activities included being in charge of the consignment operation one day a week, contributing hand-made articles for sale at the Auxiliary's fund-raising house tours, serving as chairman or co-chairman at times.

Also during this period she played a major role in the twice-a-year Haddonfield Red Cross Blood Drive, contacting donors, scheduling appointments and record keeping. Jini served several times as chairman of the drive.

Bill was an avid outdoorsman, and a favorite vacation involved fly fishing in Maine. He found a cabin on Grand Lake Stream, where LL Bean has a fly-fishing school each year. This became a favorite vacation spot for two weeks each year, and Jini, the good sport, even took up fly fishing. Other vacation trips included visits to friends in San Diego, Florida, and a small-ship voyage to Alaska.

In 2003, they decided it was time to downsize, and after looking unsuccessfully for acceptable adult communities in New Jersey, Jini's sister, Linda, who lives in Paoli, recommended Hershey's Mill. The security and park-like surroundings were appealing.

Bill passed away in 2011. Two of their children, a son and daughter, live in New Jersey, and another daughter lives in Connecticut. Completing the family are four grandchildren and one great granddaughter.

Jini now frequently has her 96 year-old aunt Sue, with whom she has always been close, as a house guest to give her a welcome change from life in center city. Jini's comfortable home makes such entertaining a pleasure.

A Hobby Yields New Newsletter Feature


The discovery in our midst of an avid pursuer of self-guided travel, who when home, has, among other activities, become a prolific 3D puzzle constructor. This has led to a proposal to add a new column to the newsletter. Each column will feature descriptions of architecturally significant buildings from around the world,

using a 3D model to illustrate its features. The first such column follows this intro-

duction.

Our puzzle constructor and narrator will be our beloved Dear Gramps, John Klanderman, who shares his time at home between philosophizing, trip planning, and this hobby. John likes to arrange his own travel and has visited the places which will be discussed. He allows time to wander and take in the beauty of each locale. Such sightseeing has fueled his appreciation of the uniqueness of each venue, and a desire to construct models of significant buildings.

As an introduction we will first describe the puzzle constructing process which yields models of buildings.. 3D puzzles come in various sizes with differing degrees of complexity. The puzzles used in our features consist of from 500 to over 1000 pieces, and produce models ranging up to 36 inches in height. Such puzzles can be purchased new from Amazon, or previously used from ebay, at a cost in the range of 35 to 100 dollars.



Assembling the model requires a sizeable workspace where the pieces can be laid out and sorted by color. The first step is joining pieces to form the building foundation. This is followed by construction of a side of the model. The box that the puzzle comes in serves as a visual aid, as does the included illustrated instructions.

The substructure, attached to the foundation, serves to give the necessary rigidity. When completed, the sides are attached, followed by completion of the roof and attachment of special details.

While the construction of the sides is relatively

straightforward, building up specialized architectural adornments, such as domes, is trickier. In the case of a dome, it is generally necessary to reinforce the inside of the constructed dome to ensure its integrity when attached to the roof.

The models are usually constructed on a piece of foam board to facilitate moving them to the place chosen for display. The photo on the right shows a completed puzzle. The box it came in is retained for storage when the time comes to disman-



The colors of the models are like those of the real buildings, which makes for a vibrant and satisfying display. We can only encourage you to visit John's workshop and enjoy the real thing in living color. As you will see, he has been hard at work, and has a great variety of completed puzzles for you to view, with more coming. Perhaps you will be inspired to take this up as a new hobby!

Venice is a world ikon and a great travel destination either as part of an organized tour or as a place to spend a week or two and "live like the natives" as we do. You can walk to almost everything, English is spoken throughout the city, and the food and hospitality are wonderful. May is an excellent month to go because it has statistically shown to have very limited, if any, flooding. You will also be ahead of the deluge of summer tourists. However, Venice does have a lot of bridges which all have a lot of steps, and the water transportation can get pretty pricey, unless you can plan your moves carefully to make unlimited use of day or week passes.




This 3D puzzle of **VENICE** has 1580 pieces and is a typical romantic image of this beautiful eternal city, including gondolas, canals and arched bridges. Water in Venice is so omnipresent that boats are the only means of transportation. Emergency vehicles and public workers, from ambulances to trash collectors, must all use the water ways. Small motor boats are available for those in a hurry.



However, for a leisurely sightseeing tour, hop on board a vaporetto, the equivalent of a floating bus. But the famously renowned gondola, propelled by a gallant, pole-plying gondolier, still remains the most popular, if not most expensive, way of transportation for tourists.

On November 4th, 1966, a great flood, called the aqua alta, submerged the city of Venice, placing its water level at an astonishing 6 feet above sea level. Electrical and telephone lines were drowned and Saint Marc's Plaza was lost under four feet of water.



St.. Mark's Basilica, which is situated on the huge Piazza San Marco in Venice, is also well known for the Pala d'Oro which is one of the richest and most precious altar screens in the world. It is covered with more than 3000 precious stones and enamel ikons inlaid in gold. This 3D puzzle of SAINT MARC'S BASILICA has 731 pieces. This basilica is reported to be the perpetual resting place of St. Mark the Evangelist. In 828 two merchants of Venice smuggled his mortal remains from Alessandria (Egypt) and they were placed in a small, simple church. The church later suffered damage by fire and was then restored and modified many times to adapt to Venice's evolution of power and wealth. Eventually, the church became St. Mark's Basilica which continued to be modified throughout an entire century.

Hershey's Mill Master Association

(For the benefit of newcomers: Hershey's Mill is governed by a Master Association (MA) consisting of the Presidents of the villages. Matters to be considered by the MA are formulated by the five-member Board of Directors (BOD) for consideration and action by the MA.)

Editor's note: The minutes of the Master Association meetings are posted online in the MA website when available. We provide an abbreviated summary from time to time for those who do not have internet access or have difficulty finding the information. This report is strictly the interpretation of the editors, and is not to be considered an official report.

At the HM **Board of Directors** meeting in June the board met with town officials to discuss alarm system requirements when an alarm system is being upgraded or when a unit is sold. New systems must comply with the current East Goshen code.

As there was no contest, **Joe Bove** and **Boyd Mackleer** were reelected for two year terms. Joe continues as President, and Boyd is First Vice President.

Two **Board of Directors** meetings were held in August. Early in the month a status report on the Vision Quest feasibility study was presented by **Tom Daley**, the architectural consultant. He presented sketches of the three options

which have been brought forth during the Vision Quest study meetings. These include: a new pool house, year-round sports-area restrooms, multi-purpose room, meeting space, admin office, etc.

The BOD requested that he produce a fourth option, which would include some elements of each of the existing three options arranged in a slightly different format. "Order of magnitude" cost estimates were reviewed for each option which were surprisingly similar in scope.

A policy was adopted regarding the use of the tennis courts for the purpose of giving tennis lessons for a fee. Consistent with other practice, 10 percent of such fees shall be paid either to the amenity fund associated with the activity, or to the Master Association.

At the **Board of Directors** meeting held at the end of August, Tom Daley presented the Option #4 requested during the Vision Quest discussion earlier in the month. The components of this option include, in no particular order:

- 1. A rebuilt pool house
- 2. A new "Events Building" with divisible multi-purpose space, kitchen facilities, meeting rooms, office and storage.
- 3. 30 50 additional parking spaces
- 4. An elevator for the Community Center.

Daley will refine this master plan option for presentation to the MA at the October meeting along with a review of the other options that were considered previously.

In other actions, a final draft of the 2015 budget for the MA was reviewed. The BOD is endeavoring to hold the MA assessment at \$141.33 per house per month for another year. (This amount is included in your condo fees.)

Security issues were discussed. Gate mechanisms have been replaced, and the Gate Entry phones will be replaced.

It was reported that the Sullivan House committee has selected Brandywine Caterers as a sole supplier for any non-resident use of the house.

The **HM Master Association** met on September 4th. Insurance issues were discussed at length, as costs have risen significantly. It was reported that the new gate phones have been ordered and will allow guests to look up residents by last names.

A new set of vehicle regulations have been adopted covering the main roads and the amenity areas. An agreement with a towing firm to tow vehicles if those regulations are violated takes effect October 1.

In connection with the Vision Quest presentation to the entire Master Asso-

ciation, slated for October 2nd, it was noted that "Members may share the information and get feedback from councils and residents as they find appropriate."

A study of the Stormwater management system by a consultant, and various other items were also discussed.

(As you can see, there are many items under discussion which may impact all of us. It is worthwhile and important to be informed.)
