Speaking at a recent Town Hall Meeting at Hershey's Mill Community Center, Ms. Comitta spent 2 hours conversing with local residents about her role as our State Representative and in all the ways that she and her staff are able to assist all Chester County residents, proving that she is on the job for us. As a senior herself, Representative Comitta explained how she is an advocate for seniors, serving on legislative committees of Aging & Older Adults, Appropriations, and Environmental Resources & Energy. Ms. Comitta previously served 2 terms as the first bipartisan elected mayor of West Chester. Now in Harrisburg, she is able to make connections with leaders of both major parties to get things done for all Chester County residents.



At the Town Hall meeting, Rep. Comitta told her audience that they are welcome and encouraged to call her office for virtually any troublesome issue. She and her staff can easily cut through the bureaucratic red tape that often stymies citizens. Whether in dealing with PennDOT, SEPTA, or the Sunoco Pipeline her office can get quick results. Representative Comitta updated those in attendance about a number of current issues including PA efforts to address Climate Change,

Gun Law Reform, Property Tax Relief proposals, Gerrymandering and the status of Redistricting. She also brought us up to date on local concerns like maintaining Open Spaces, Fair Distribution of School District Funds, and the attempts of local and state government to control the effects of the Sunoco pipeline construction. She answered all resident questions clearly, explaining the facts in language that was easy to understand.

#### 2020 BUDGET AND VINYL SIDING PROJECT UPDATE REPORTED AT NOVEMBER OPEN MEETING

NEARLY 100 RESIDENTS ATTENDED the Open Meeting of Jefferson Village HOA on November 13, despite the unusually cold weather. Following the now-standard (and ever-popular) Wine & Cheese Social, residents were introduced to the current council members and to our managing agent, Steve Erney. Special tribute was given to Becky Green for her many years of service to Jefferson Village. Mike Allen was introduced as Becky's replacement on the Council. Selected by Council according to village bylaws, Mike will serve the remainder of Becky's term on Council. Mike Gibson was introduced as new Landscape Committee chair, and Peggy Del Fuoco was announced as the new chair of the Social Committee.

A State-of-the-Village report was given by Council Member Steve Friedrich. The vinyl siding project was on schedule for completion by end of January 2020. Nearly 2/3 of village buildings have been completed, and residents were given a tentative schedule for the onset of remaining construction dates. Painting of trim and doors will continue until it becomes too cold to paint outdoors, then resume with warmer temperatures in the Spring. It is hoped that stucco repairs will be done in 2020 as well. Council is also looking into replacing mailboxes and street light globes in the near future as well. Other ongoing Council projects include the arbor thinning program and a variety of storm water diversion endeavors to correct deviant water flow caused by a variety of environmental issues. Council has also authorized a reserve study project for 2020 to make sure that plans for repair and replacement of roofs, drives and infrastructure remain on target and properly funded.

Council Member Mike Gibson presented the Village Budget for 2020. Mike reported the 2019 budget

remains on target, and explained the changes needed for next year. While budget estimates for general maintenance and snow removal have gone there down. were unavoidable increases in utility costs, landscaping budget (mostly for tree removal) a n d our contribution to the Hershey's Mill master Association. This resulted in a net increase in homeowner dues of \$11 per month. It is interesting to note that 1/3 of our dues goes to the Master Association, and over 1/3 of that amount goes towards our telecommunications utilites of Cable TV, phone and internet.

#### AMAZON DELIVERY WOES ???

Amazon delivery drivers often have a difficult time delivering packages to Hershey's Mill addresses. This often leads to unauthorized entry, broken gates or packages being left unattended at one of the entry gates. Hershey's Mill Security recommends the following procedure to ensure your Amazon orders get delivered properly.

- When you "proceed to checkout," under the shipping address is a link to "Add Delivery Instructions." Click this link and select the drop-down box "Do we need additional instructions to find this address?" Type in the box: I live in Hershey's Mill, a gated community. The delivery driver will need to access my delivery address via the Hershey's Mill Main Gate entrance at 1500 Greenhill Road, West Chester, PA 19380."

In most cases, these instructions remain attached to your address for all future Amazon.com deliveries (but it's always good to check.)
