Message from the President

Sometime in mid-October we should be able to see the warm red hue of what appears to be a very large moon. As with most things in the sky, the phenomenon of the Harvest Moon is simply the result of some very natural occurrences. The low hanging moon deceives the brain into thinking it's larger than one that is high in the sky. While the warm color of the Moon, shortly after it rises, is caused by light from the Moon passing through a greater amount of atmospheric particles than when the Moon is overhead. While all of this may be scientifically true, mid-October is still a beautiful and romantic time of the year and one that we can all recall in the fondest memories of our youth.

And then comes Halloween with its witches and goblins, born of superstition and the supernatural. This day originally marked the New Years Eve for the ancient pagan Celts and the beginning of the dark half of the year. Never was the mischievous element of the spirit world closer to the Celts than on this day. The traditions of Halloween which we celebrate in this country today were brought here by Irish and Scottish immigrants who lived these Celtic customs. Speaking of mid-October, we expect that Xtreme will have completed rehab of 76 of the village chimney caps, including the worst of the caps, all of the exhaust vents and replacement of the PVC vent pipe rubber collar and flange, where necessary. The remaining 76 chimney caps will be scheduled for

rehab by Xtreme during the spring of 2013. As I previously stated in the July Newsletter, due to the cost associated with the number of chimney cap units involved, it was decided to split the total chimney cap rehab between the two calendar years. This would give council the ability to determine the actual positive balance of the operating budget for 2012 and plan for the remaining expense in 2013.

The alarm testing and cleaning project by Jarman Electric continues as scheduled. It is expected that this will be completed by the end of this week. Remember that access to your home will be required to conduct this service. You were informed of your scheduled date by mail from CSK on August 15; please review your date and ensure that you or someone else will be available to allow entry at that time or contact CSK otherwise.

Arrangements are currently being planned to distribute, to all Yardley Village residents, a rewritten Declaration of Covenants and Easements of Yardley Village and By Laws. Both of these documents were originally "hand-me-downs" prepared by KHovnanian for any and all of their developments. The need for a rewrite was recognized, and conducted over an extended period of time and reviewed by legal counsel. Council has not

attempted to change any material aspects of the original documents but only to relate all the items contained in them to Yardley Village specifically and to extract items that were not pertinent to Yardley Village.

Also, included in the distribution will be copies of various pages that should be incorporated into your Village of Yardley Rules and Regulations notebook. These pages include corrections and modifications to the existing R&R's.

Since a significant amount of paper is involved with the total distribution, the current plan is to notify all residents when sets of the above documents are available. At such time, all residents will be asked to pick up and sign off for receipt of these documents during a specific time, at a particular location within Yardley Village. Hopefully, this will allow for all residents to receive and sign for all of their material with the least amount of effort on any one particular group of people.

As you know, dryer vent cleaning was recently offered to be done for you at the exceptionally reasonable price of \$40 by Kevin Free. Council has been made aware of a number of potential fire hazards found during the cleaning process including unattached vent ducts causing lint falling near or upon gas hot water heaters. Council is considering the requirement for homeowners to conduct such cleaning or provide documentation that it has been completed in the recent past. This action will be reconsidered at the next Council meeting when all information is obtained regarding the number of homes that did not avail themselves of the above service.

While I continue to distribute the minutes of the monthly Hershey's Mill Board of Director meetings and the Hershey's Mill Master Association meetings, I do not do so with the Yardley Village Council meetings. For your information, the approved minutes for these meetings are being posted on a regular basis to the Yardley Village Website. This

website is available through the updated Hershey's Mill website at www.hersheysmill.org. Our Web Manager, Roger Fleming, provides this information on the site each month at no small effort on his part. So, I would ask you to avail yourself of this service and find out what the Yardley Council is secretly plotting.
